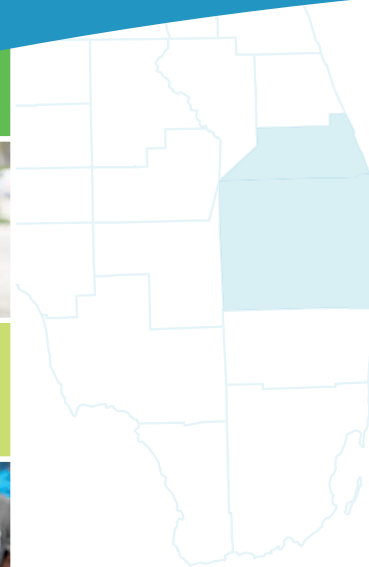

2. THROUGH A DONOR-ADVISED FUND (DAF)

DAFs are a simpler, more flexible and efficient alternative to creating a private foundation. You can contribute as often as you would like, receive the maximum tax deductions allowed, and direct the Community Foundation to administer your dollars to the charities of your choice.

The Community Foundation is the only organization that can guarantee your money will work for the community forever through our **Donor-Advised Endowment Funds**.

Priority FUNDS

The **COMMUNITY IMPACT FUND** serves as the primary funding pool for our annual competitive grants cycle, which funds our area's greatest needs at any given time.

A rigorous application and oversight process ensures competitive grant recipients have the capacity, programming, track record, and talent in place to make an immediate difference.

By contributing to this fund, you directly support over 100 community-focused organizations each year that close opportunities gaps in education, economic opportunities, and community-wide issues like housing, literacy and mental health.

Since 1985, the Community Foundation for Palm Beach and Martin Counties' **SCHOLARSHIP FUNDS** have helped reduce the burden of debt for our area's promising college students through need- and merit-based scholarships.

As a scholarship donor, you have the option of supporting one or more of three critical areas:

1. **Traditional four-year programs:** Supports students with financial assistance to offset the costs of tuition and fees
2. **Emergency and wrap-around services:** Supports students by providing them with funds to pay for food, rent, and transportation in times of need
3. **Trades and vocations:** Supports students interested in pursuing a skilled trade as a career
